The Legislature of the County of Niagara, State of New York, convened in annual session in the Legislature Chambers, Courthouse, Lockport, New York on Tuesday, January 6, 2026 for the purpose of electing officers for the ensuing year.

County Clerk Joseph Jastrzemski, acting as Chairman pro temp, called the Legislature meeting to order at 6:05p.m

A moment of Silence was held for former legislator Owen T. Steed and former Town Justice and Supervisor of the Town of Wheatfield Robert Cliffe.
