

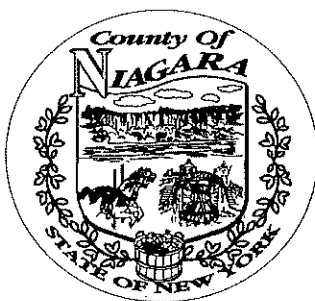



ADOPTION OF THE NYS GENDER BASED VIOLENCE AND THE WORKPLACE POLICY FOR NIAGARA COUNTY

WHEREAS, New York Finance Law Section 139-M requires bidders on competitive state procurements to certify that they have a written policy addressing gender-based violence and the workplace and that such policy meets the requirements of NYS Finance Law Section 139-M, and

WHEREAS, Niagara County will share and make this policy available to all employees, supervisors and managers to provide information regarding gender-based violence and resources available including through the NYS Office for the Prevention of Domestic Violence for information and support, and

WHEREAS, Niagara County policy provides that no person shall be subjected to unlawful discrimination or retaliation based on race, creed, color, gender, age, national origin, religion, disability, sexual orientation, marital status, familial status, prior arrest or conviction record, predisposing genetic characteristics, pregnancy-related conditions, victim of domestic violence and gender-based violence, or veteran status, and

WHEREAS, the County of Niagara shall incorporate throughout all of its operations the requirements of applicable State and Federal laws and executive orders to prohibit any discriminatory practices, procedures and policies, including retaliation against those employees who identify as victims or survivors of domestic and gender-based violence, and

WHEREAS, all administrators, managers, supervisors and employees will be directed to comply with this policy and applicable laws including but not limited to the NYS Human Rights Law, and

WHEREAS, this policy will be placed on all Niagara County bulletin boards, HR website, and shared with new hires during new hire orientations, and communicated annually as a reminder thereafter, and

WHEREAS, any employees that have a concern relative to domestic and gender-based violence or that witness another employee being subjected to such acts shall discuss the concern with their Department Head or designee and also contact the Human Resources Department at 716 438-4068 or 716 438-4069 for assistance, guidance, and to develop a workplace safety plan, and

WHEREAS, employees can also contact the Niagara County Employee Assistance Program at 1-800-252-4555 or the NYS Domestic and Sexual Violence Hotline at 1-800 942-6906 for support and referrals, and

WHEREAS, the County of Niagara has developed this policy to comply with NYS Finance Law Section 139-M, now, therefore, be it

RESOLVED, that the County of Niagara hereby adopts the Niagara County NYS Gender Based Violence and the Workplace Policy.

ADOPTION OF THE UPDATED COUNTY OF NIAGARA TITLE VI CIVIL RIGHTS PLAN

WHEREAS, Niagara County DPW and other departments receive federal funds and as a result NYSDOT requires that the County of Niagara Title VI Civil Rights Plan be updated every three (3) years, and submitted to and approved by the NYS DOT, and

WHEREAS, it is the policy of the County of Niagara to prevent and eliminate discrimination in all of its operations and services as well as all aspects of employment, and

WHEREAS, the goal of the County of Niagara is that all Departments, Divisions, Offices, and Bureaus plan, develop and implement their programs and activities so that no person is subjected to unlawful discrimination based on race, creed, color, gender, age, national origin, religion, disability, sexual orientation, marital status, familial status, prior arrest or conviction record, predisposing genetic characteristics, pregnancy-related conditions, victim of domestic violence or gender based violence, or veteran status, and

WHEREAS, the County of Niagara shall incorporate throughout all of its operations the requirements of applicable state and federal laws and executive orders to prohibit any discriminatory practices, procedures and policies, and

WHEREAS, all administrators, managers, supervisors and employees will be directed to comply with these laws and orders, and

WHEREAS, the County of Niagara is committed to maintaining an agency which recognizes and values the inherent worth and dignity of every person; fosters tolerance, sensitivity, understanding, and mutual respect among its workforce; and encourages each individual to strive to reach their own potential, and

WHEREAS, this policy will be placed on all Niagara County bulletin boards and made available to all organizations and entities doing business with the County of Niagara, and

WHEREAS, any complaints involving allegations of discrimination will be sent to the Human Resources Director and Title VI Coordinator, Niagara County Human Resources Department, 111 Main Street, Suite G2, Lockport, New York 14094 (716) 438-4068, and

WHEREAS, the County of Niagara shall continue to develop short term and long term transit and transportation projects, including roads, bridges, and infrastructure construction, maintenance, and repairs and regular servicing projects for the efficient transportation services to the citizens of the County, and

WHEREAS, the County of Niagara shall continue to plan, develop and provide and maintain many other critical support services to the citizens of the County, and

WHEREAS, the County of Niagara as an organization shall continue to coordinate and administer a wide array of critical services and support that will ensure that all segments of the population have been informed of these available services including, where applicable, the involvement with the planning process, and

WHEREAS, the goal of Title VI is to ensure that services and benefits are fairly distributed to all people regardless of race, national origin or income, and they have access to meaningful participation, and

WHEREAS, the County of Niagara has developed a Title VI (Civil Rights) Plan that outlines the plan for the County of Niagara to address the Title VI requirements for the County of Niagara, now, therefore, be it

RESOLVED, that the County of Niagara hereby adopts the updated Title VI (Civil Rights) Plan incorporated herein and made a part hereof by reference, and be it further

RESOLVED, that the County Manager be and is hereby authorized and directed to sign the updated Title VI (Civil Rights) Plan and submit the same to the DOT for review and approval
