The Legislature of the County of Niagara, State of New York, convened in annual session in the Legislature Chambers, Courthouse, Lockport, New York on Tuesday, January 3, 2017 for the purpose of electing officers for the ensuing year.

County Clerk Joseph Jastrzemski, acting as Chairman pro temp, called the Legislature meeting to order at 7:01 p.m. and gave the invocation and pledge.

All Legislators were present with the exception of Legislators Virtuoso and Zona.

The Chairman pro temp Joseph Jastrzemski asked for nominations for temporary Chairman. Moved by Syracuse, seconded by Godfrey, that Legislator Burmaster be nominated for temporary Chairman. Moved by Syracuse, seconded by Godfrey, that the nominations be closed. Carried.

Chairman pro term Jastrzemski declared Legislator Burmaster as the temporary Chairman.

Temporary Chairman Burmaster asked for nominations for permanent Chairman. Moved by Burmaster, seconded by Nemi, that Legislator McNall be nominated for permanent Chairman. Moved by Burmaster, seconded by Nemi, that the nominations be closed. Carried.

Moved by Andres, seconded by Lance, to appoint Mary Jo Tamburlin as the Clerk of the Legislature. Moved by Andres, seconded by Lance, to close nominations. Carried.

Mary Jo Tamburlin was declared the Clerk of the Legislature.

Legislator Bradt announced that Legislator Bradt would serve as Majority Leader, Legislator Syracuse as First Deputy and Legislator Hill as Second Deputy Majority Leader.

Legislator Grozio announced that Legislator Virtuoso would serve as Minority Leader, Legislator Zona as First Deputy and Legislator Steed as Second Deputy Minority Leader.
