



ACADEMIC INVESTMENTS**

WHEREAS, the County of Niagara, and Niagara County Community College acknowledge and embrace the need to provide a modern Academic environment so that educational services can be delivered, and

WHEREAS, the Administration of Niagara County Community College has identified several areas of need to remain competitive within the Western New York higher education arena, and

WHEREAS, the proposed capital funding total of \$450,000, which includes renovations of E-Building Lecture Hall(s) and purchase of furniture/equipment to support the Student collaborative environment, and

WHEREAS, the NCCC Foundation has pledged the amount of \$225,000 as the local sponsor share in support of this funding request to SUNY for a corresponding match, now, therefore, be it

RESOLVED, that the County of Niagara, as the sponsor of the college, does hereby support the proposed capital funding for Academic & Student Space Investments, and be it further

RESOLVED, that the County of Niagara is requesting SUNY to provide a 50% match of the total capital amount of \$450,000; the amount requested from SUNY is \$225,000.

WHEREAS, the County of Niagara, and Niagara County Community College acknowledge and embrace the need to invest in energy infrastructure allowing for recued carbon emissions and operational savings, and

WHEREAS, the Administration of Niagara County Community College has identified the need to align its Electrical Energy sources with, state and federal guidance, and

WHEREAS, the proposed capital project totaling \$15,000,000 which includes but not limited to construction of up to a (6) megawatt solar farm, and

WHEREAS, the Federal Government is providing federal subsidies valued at 30% of the total projected cost in the amount of \$4,500,000 as the local sponsor share in support of this funding submission to SUNY, and

WHEREAS, the remaining 40% of the total project cost will be provided via a Power Purchase Agreement with the developer through energy savings, now, therefore, be it

RESOLVED, that the County of Niagara, as the sponsor of the college, does hereby support the proposed capital funding for installation of a solar farm up to (6) megawatts, and be it further

RESOLVED, that County of Niagara is requesting SUNY to provide a 50% match of the total fundable capital amount of \$9,000,000; the amount requested from SUNY is \$4,500,000.





NIAGARA COUNTY CLERK'S OFFICE
BUDGET MODIFICATION – INTER-MUNICIPAL AGREEMENT – MAINTENANCE AND CARE AGREEMENT

WHEREAS, the County of Niagara with offices at 175 Hawley St, Lockport, New York 14094 and the City of North Tonawanda, New York, with offices at City Hall, 216 Payne Avenue, North Tonawanda, NY 14120, have entered into an Inter-municipal, maintenance and care agreement, and

WHEREAS, the City of North Tonawanda currently owns 611 Shad Street (a/k/a 500 Wheatfield Street), North Tonawanda, New York 14120, SBL 182.14-1-1 (the "Property"), and

WHEREAS, the County of Niagara currently provides Department of Motor Vehicle and Probation Services to residents of the City at the Property, and

WHEREAS, it is beneficial to the residents of North Tonawanda to have a DMV location within their City for convenient access to its services, as well as for residents for Probation Services, and

WHEREAS, upon commencement of the inter-municipal agreement between the County of Niagara and the City of North Tonawanda, the County shall pay the City One Hundred and Seventy-Five Thousand Dollars (\$175,000.00) as a lump sum payment to continue providing services to the residents at the Property, and

WHEREAS, that One Hundred and Fifty Thousand (\$150,000.00) of that payment shall be used towards capital improvements on the Property, and

WHEREAS, this payment covers all amounts owed by the County to the City from the expiration of the contract for sale/lease through the end of the term of the agreement, and

WHEREAS, The City will continue to be responsible for all maintenance and cleaning at the property, and

WHEREAS, the County will continue to pay their proportionate share of utility charges, and

WHEREAS, the 2024 County Clerk budget will need to be modified to accommodate the terms of the Inter-Municipal maintenance and care agreement between the County of Niagara and the City of North Tonawanda, now; therefore, be it

NIAGARA COUNTY SHERIFF'S OFFICE ACCEPT BJA FY2022 CRIMINAL ALIEN ASSISTANCE PROGRAM GRANT

WHEREAS, the Niagara County Sheriff's Office has been notified by the US Department of Justice of an award of funds under the Bureau of Justice Assistance FY2022 State Criminal Alien Assistance Program (SCAAP), and

WHEREAS, under this program the Department of Justice makes payments to eligible states and local governments that incur certain types of costs due to incarceration of undocumented aliens during a particular 12 month period, and

WHEREAS, the grant award to the Niagara County Sheriff's Office is \$4,008 which is used to offset the cost of correction officer salaries, and

WHEREAS, the Niagara County Sheriff's Office also pays a 22% commission to Justice Benefits, Inc to facilitate the collection of data for the grant as well as the application process which is in the 2023 Budget, now, therefore, be it
