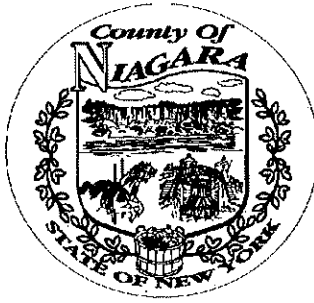



WHEREAS, the parties wish to memorialize their agreement with the execution of an Inter-Municipal Cooperation Agreement, a copy of which is incorporated by reference, now, therefore, be it

**MH BUDGET MODIFICATION – PARTICIPATE IN HEALTHCARE WORKERS BONUS**

WHEREAS, Governor Hochul launched the Health Care Worker Bonus Program pursuant to Part ZZ of Chapter 56 of the Laws of 2022, and

WHEREAS, the Health Care Worker Bonus Program allows qualified employers to issue bonus payments to frontline health care workers to "recruit, retain, and reward health care and mental hygiene workers" meeting specified eligibility requirements, and

WHEREAS, the bonus amounts will be commensurate with the number of hours worked by eligible workers covered by the Health Care Worker Bonus Program during the five designated vesting periods for up to a total of \$3,000 per covered worker, and

## A RESOLUTION CALLING ON GOVERNOR HOCHUL TO SIGN LEGISLATION REQUIRING SHORT-TERM HOME RENTAL AGENCIES TO COLLECT SALES TAX AND HOTEL/MOTEL OCCUPANCY TAXES

WHEREAS, legislation was passed by the New York State Assembly and Senate (S.885-C and A.4130-C) which would require short-term home rental agencies, such as VRBO and Airbnb to collect sales tax and hotel/motel occupancy taxes, and

WHEREAS, it was recently announced that Airbnb will begin collecting taxes in Erie County for vacation rental properties booked through their system, and

WHEREAS, Niagara County, as recently as three years ago, had previously pursued a voluntary collection agreement with Airbnb but ultimately no agreement was reached, and

WHEREAS, three entities in Niagara County currently collect bed tax revenue from hotel and motels -- the county, the City of Niagara Falls and the City of Lockport -- but not short-term rentals, and

WHEREAS, not only does this deprive the municipalities of revenue, but it creates an uneven playing field between hotels/motels and short-term rentals, now, therefore, be it

RESOVLED, that the Niagara County Legislature urges Governor Hochul to sign S.885-C/A.4130-C into law, and be it further

RESOLVED, that absent action by the Governor, the county attorney is directed to formally request Airbnb to begin collecting bed taxes on rentals similar to their efforts in Erie County.

## A LOCAL LAW INCREASING THE MAXIMUM ALTERNATIVE VETERAN'S EXEMPTION

WHEREAS, Legislators Irene Myers, Rebecca Wydysh, Randy Bradt, Anthony Nemi, Christopher Voccio, Jesse Gooch, Richard Andres, David Godfrey, Richard Abbott, Shawn Foti, Michael Hill and Christopher McKimmie present in writing the following proposed Local Law:

A Local Law of the County of Niagara, New York, for the year 2024, in relation to the Alternative Veteran's Exemption from Real Property Taxation under Section 458-a of the Real Property Tax Law (RPTL) of the State of New York, and

Be it enacted by the Legislature of the County of Niagara, New York, as follows:

Section 1. The purpose of this law is to increase the maximum exemption allowable in Real Property Tax Law, Section 458-a(2) a, b, and c to \$30,000, \$20,000 and \$100,000 respectively.

Section 2. This local law shall take effect immediately upon its filing with the Secretary of State

RESOLVED, that the Niagara County Legislature shall conduct a public hearing upon said proposed Local Law at the Legislative Chambers, Niagara County Courthouse, Lockport, New York, on the 15<sup>th</sup> day of October, 2024 at 5:50 p.m., and be it further

RESOLVED, that the Clerk of the Legislature, at least six (6) days in advance of such hearing, shall post a notice upon the bulletin boards in the Courthouse in Lockport, the Civic Building in Niagara Falls shall publish such notice once in the Union Sun & Journal, and the Niagara Gazette; such notice shall contain the title of the Local Law and an abstract of the text to be prepared by the Clerk of the Legislature, with the assistance of the County Attorney's Office
