RESOLUTION AUTHORIZING INTERMUNICIPAL AGREEMENT WITH THE CITY OF LOCKPORT FOR 2022 AND 2023 CITY IN REM PROCEEDINGS

WHEREAS, the City of Lockport has instituted In Rem actions under Niagara County Supreme Court Index #E176714/2022 and #E178984/2023, for the foreclosure of certain tax liens for the year 2021 and 2022 against various parcels of land situate within the City of Lockport, New York, pursuant to the provisions of Article 11, Title 3 of the Real Property Tax Law of the State of New York, and

WHEREAS, the provisions of said law authorize and empower tax districts having an interest in various parcels to enter into an agreement making provisions for conveyance of said parcels without public sale, and upon such terms as said districts may agree upon between themselves, and

WHEREAS, the parties hereto have conferred and negotiated as to the method of handling the various parcels included in said action, and

WHEREAS, the parties wish to memorialize their agreement with the execution of an Inter-Municipal Cooperation Agreement, a copy of which is incorporated by reference, now, therefore, be it

RESOLVED, that the Chairman be and is hereby authorized and directed to enter into an inter-municipal cooperation agreements with the City of Lockport regarding the City of Lockport 2021 In Rem action filed with the Niagara County Supreme Court under Index #E176714/2022 and 2022 In Rem action filed with the Niagara County Supreme Court under Index #3178984/2023.
