



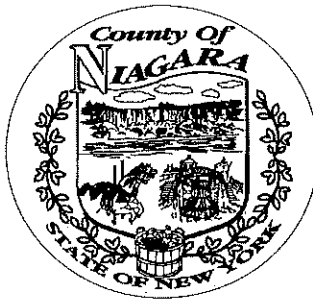

**RENEWAL OF CONTRACT WITH ENTERPRISE TRAINING SOLUTIONS, INC. FOR

WHEREAS, the County of Niagara is required to comply with new NYS requirements to provide annual training to all employees and separate higher level training for supervisors/managers on the Niagara County Sexual Harassment Prevention Policy, and

WHEREAS, the County of Niagara has determined that the most efficient means to comply with this new requirement is to provide the majority of the training with the use of technology whereby employees conduct interactive online training in a self-paced approach, on an annualized basis as required by regulation, and

WHEREAS, the County of Niagara has selected to engage in a professional services contract with Enterprise Training Solutions, Inc. which is on State contract through the Office of General Services (OGS), award # 22883 for Group 73016 – e-Learning/Distance Learning Training Services (Statewide) for the time period of January 15, 2025 through January 14, 2028, and

WHEREAS, the County of Niagara wishes to renew the contract and continue to partner with Enterprise Training solutions, Inc. for an additional 3-year contract, and

WHEREAS, the annual fee for the aforementioned online trainings, and a third training topic (to be determined) of the new contract term shall continue to be \$16,000 each year and

WHEREAS, prior to the execution of the contract, the County Attorney will review the contract for approval as to legal form, language and compliance, now, therefore, be it



## AUTHORIZATION FOR REAL PROPERTY TAX REFUNDS/CORRECTIONS – 2025

WHEREAS, New York State Real Property Tax Law, sections 554 and section 556, provides for an administrative correction of error process that assists property owners in obtaining refunds and/or corrections for real property tax payments or billings, and

WHEREAS, certain clerical errors, unlawful entries and errors in essential fact, as defined in the New York State Real Property Tax Law, are permitted to be corrected by a taxing jurisdiction based upon the recommendation of the Director of Real Property Tax Services, and

WHEREAS, the taxing jurisdiction can delegate, by resolution, on an annual basis, to an official who is empowered to authorize payment of bills without prior audit, the authority to perform the duties of the tax levying body in regard to Real Property Tax Law, Sections 554 and 556, now, therefore, be it

RESOLVED, that the Niagara County Treasurer is hereby, delegated the authority to perform the duties of the tax levying body during 2025 when the Real Property Tax Director's recommended refund and/or correction is twenty five hundred dollars or less, and be it further

RESOLVED, that on or before the fifteenth day of each month, the Niagara County Treasurer shall submit a report to the Niagara County Legislature of the refunds and or corrections processed during the preceding month, containing the name of each recipient, the location of the property, and the amount of the refund.

**RECONNECT PROGRAM GRANT AND SECURITY AGREEMENT FOR

WHEREAS, Niagara County as principal awardee and Orleans County as co-awardee have been provided congressionally directed spending under the consolidated appropriations act, 2022, public law 107-103(the FY2022 appropriations), and

WHEREAS, to implement the congressionally directed spending an award letter has been issued for the grant designation of project NY 1709 A70, which is for the Orleans County construction of broadband infrastructure, and

WHEREAS, in order for Orleans County to receive the grant award it is required that both the principal awardee, Niagara County, and Orleans County as a second awardee are required to execute the Reconnect Program Grant and Security Agreement in order for Orleans County to receive their award for project NY1709-A70, and

WHEREAS, that due to this requirement of RUS; Orleans County has agreed to and executed an Indemnification and Hold Harmless Agreement, that fully holds Niagara County without liability or cost; which Orleans County fully agrees to indemnify and hold harmless Niagara County from any and all liability, cost or expense that may be involved with the Reconnect Program Grant and Security Agreement that is required to be executed by Niagara County and Orleans County, and

WHEREAS, that without the execution by Niagara County the award under project NY 1709-A70 would not be available to Orleans County to complete and put into effect their rural broadband infrastructure program, now, therefore, be it

RESOLVED, the Reconnect Program Grant and Security Agreement for the project designated NY 1709-A70, and any required documents to implement said agreement may be executed pursuant to the Niagara County Contract Policy after review and approval by the Niagara County Attorney.





RESOLVED, that the low bid, as outlined on the attached result sheet, be awarded to LaBella Associates, DPC.



WHEREAS, the HCRSA entitles the County of Niagara to 9 megawatts of low cost power allocation (at 70% load) from the New York Power Authority, and

WHEREAS, the County of Niagara has made the use of this low cost power allocation for economic development purposes as the top priority for that allocation, and

WHEREAS, there is presently an Agreement for the Sale and Purchase of Niagara Project Power and Energy ("ASPNPPE") that has been approved by the County of Niagara and NYPA and the Governor of the State of New York, and

WHEREAS, the ASPNPPE specifically provides that the County of Niagara could use its low cost power allocation for economic development purposes, and

WHEREAS, the County of Niagara has taken the necessary actions to fully implement the benefits contained in the HCRSA and the ASPNPPE, and

WHEREAS, the County of Niagara established the Empower Niagara Board by Resolution ED-021-07 to review applications for the use of low cost power for economic development by reviewing applications and to make recommendations to the Legislature of Niagara County, and

WHEREAS, the County of Niagara has previously awarded to Virtual Polymer Compounds, LLC for this same project under resolution ED-002-22, 200 kw (at 70% load factor), which agreement will expire on January 31, 2025 and for which Virtual Polymer Compounds, LLC has met each part of the previous application, and

WHEREAS, the Empower Niagara Board has reviewed the extension request of Virtual Polymer Compounds, LLC for the use of low cost power to allow it to remain competitive in Niagara County and Virtual Polymer Compounds, LLC has met or exceeded each part of the previous application, including an increase in its workforce from 38 to 53 employees, an expansion of production capacity through new equipment and processes that lower costs and improve efficiency, and a significant capital investment which has led to an increase in sales from \$4.8 million in 2021 to \$8 million in 2023, and

WHEREAS, Virtual Polymer Compounds, LLC has implemented several energy efficiency projects, including elimination of two large inefficient air handling/heating units, installation of an energy management system and the conversion to LED lighting throughout the entire complex, and

WHEREAS, Virtual Polymer Compounds, LLC has purchased nearly \$250,000 in services from fifteen Niagara County companies, which has expanded its economic impact to Niagara County, and



WHEREAS, the approval of Big Ditch Brewing Company application for 248 kw (at 70% load factor) of low cost power will not only increase economic development in the City of Lockport and Niagara County, but will also assist Big Ditch Brewing Company to remain competitive in the craft brewery and restaurant business and will have a good economic effect on the community in Niagara County, and

WHEREAS, the Empower Niagara Board will be recommending the approval of the application for low cost power allocation of 248kw (at 70% load factor) for a period of three (3) years commencing February 1, 2025, now, therefore, be it
