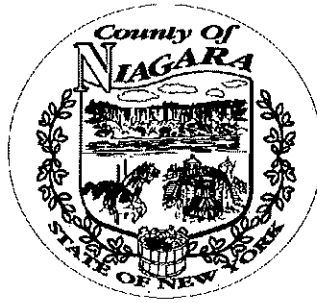





WHEREAS, Avenu Insights and Analytics, LLC has been acquired by Neumo Group, LLC effective mid-September, 2025, and


