





**REQUESTING THE ENACTMENT OF A BILL AUTHORIZING AND EMPOWERING THE
COUNTY OF NIAGARA TO EXTEND THE ADDITIONAL RATE OF ONE PERCENT
SALES AND COMPENSATING USE TAX**

WHEREAS, the County of Niagara thereafter deemed it necessary to extend the additional one percent (1%) sales tax, as set forth in Home Rule Message Resolution CW-008-23 adopted April 25, 2023 and imposition resolution CW-028-23 adopted August 1, 2023 to enable the County of Niagara to continue to offset the cost of the local share of mandated Medicaid costs, and

WHEREAS, the extension of the one percent (1%) rate was imposed from the period beginning December 1, 2023 and ending November 30, 2025, and


WHEREAS, the Niagara County Legislature hereby finds that it is necessary to further extend the additional one percent (1%) sales tax for the period beginning December 1, 2025 and ending November 30, 2027 to enable the County of Niagara to continue to offset the cost of the local share of mandated Medicaid costs, now, therefore, be it

RESOLVED, that the Niagara County Legislature requests and urges the New York Senate to work with the New York State Assembly, along with the Governor to enact a bill to authorize the County of Niagara to continue to impose an additional one percent (1%) rate of tax for the period beginning December 1, 2023 and ending November 30, 2027 in addition to the three percent (3%) the County is authorized to impose and to dedicate the funds from the additional one percent (1%) rate to the payment of the local share of Medicaid costs, said authorization in the form of a Senate Bill and an Assembly Bill.





HEALTHCARE CONSULTING**

WHEREAS, a proposal for standalone healthcare consulting services for the Niagara County Healthcare Plan was received by County Purchasing from Premier Consulting, now Assured Partners, in 2018, and

WHEREAS, healthcare consulting services have been provided under a Proprietary Buyout Agreement between NOVA, the County's TPA for medical claims administration and placement of stop loss reinsurance and Premier's founder Bill Brothers, and

WHEREAS, NOVA has advised Assured Partners and the County that said Agreement has concluded as of December 31, 2024, making the standalone proposal contingency operational, and

WHEREAS, said proposal will be honored at the 2018 pricing offered, and

WHEREAS, the County will thereby realize a cost savings over and above the current market industry standard and maintain continuity of service, benefiting the Niagara County Health Plan and its Members, now, therefore, be it,

RESOLVED, that Niagara County Risk Management is authorized to waive RFP for this professional service, thereby allowing the Niagara County Health Plan to execute a contract reviewed by the County Manager and approved as to legal form by the County Attorney.

RENEWAL OF ELIMINATION OF NIAGARA COUNTY TAX FOR CITY OF LOCKPORT WATER SUPPLY LINE

WHEREAS, the City of Lockport raw water intake is in North Tonawanda, and

WHEREAS, the raw water line intake travels from North Tonawanda through the municipalities of Pendleton, Wheatfield, Town of Lockport and North Tonawanda for a total of 13 miles to get to the City of Lockport Summit Street filtration plant, and

WHEREAS, the City of Lockport prior to June 17, 2007, paid Niagara County property tax based upon the assessment of the raw water line which resulted in a water bill increase for each homeowner in the City of Lockport, and

WHEREAS, a 100% tax exemption for the City of Lockport from the Niagara County taxes on the above described 13 mile raw water line resulted in a tax levy impact of less than one cent per thousand of assessed property values, and

WHEREAS, the County passed resolution IL-046-08 on June 17, 2008 granting a tax exemption for a period of five years upon the condition that the savings be deposited into a fund designed for and used to repair or replace damaged Lockport City owned water lines thereby providing lower water bill costs to the City of Lockport residents who are residents of the County of Niagara as well, and

WHEREAS, the County passed Resolution IL-045-18 extending the exemption for an additional five (5) years until March 1, 2024, and

WHEREAS, the County passed Resolution IL-014-24 extending the exemption an additional one (1) year until March 1, 2025, and

WHEREAS, the City of Lockport and the County of Niagara desire to renew said exemption for another three years, and


WHEREAS, the City of Lockport set up an account to deposit said savings for repairs and improvements, and the Department of Utilities prepared and submitted a plan each year to the Mayor and Common Council for expenditure in accordance with the above, now, therefore, be it

RESOLVED, that the County Attorney be directed to prepare the proper documents between the City of Lockport and the County of Niagara to finalize a 100% county tax exemption arrangement on the above described water intake line for an additional three years, until March 1, 2028.

A RESOLUTION REQUIRING THE USE OF LICENSED FUNERAL DIRECTORS OR FUNERAL HOMES FOR BODY REMOVAL AND TRANSPORT BY NIAGARA COUNTY CORONERS

WHEREAS, the dignity and respect of deceased individuals and their families are of utmost importance to Niagara County, and

WHEREAS, the removal and transportation of deceased individuals require professionalism, proper care, and compliance with New York State laws and regulations, and

A RESOLUTION FOR HARRIET TUBMAN UNDERGROUND RAILROAD NEW YORK SCENIC BYWAY NOMINATION AND CORRIDOR MANAGEMENT PLAN ADOPTION

WHEREAS, the historic qualities of the Harriet Tubman Underground Railroad New York Scenic Byway, as described in the corridor management plan, and the surrounding areas have been appreciated and celebrated for over a century by the residents of New York State, as well as tourists, historians, artists, authors, and other visitors to the region; and it is this unique combination of the journeys of Harriet Tubman and those Freedom Seekers who traveled on the Underground Railroad that create the special sense of place that is vital in telling the New York story of the human desire for freedom and the historic sites they utilized during their journey to emancipation, and

A RESOLUTION OPPOSING NATIONAL GRID RATE HIKE PROPOSAL

WHEREAS, Governor Hochul last week issued a press release demanding that the New York Power Authority (NYPA) suspend its proposed rate hike on customers to protect consumers from sky-high utility costs that are making New York State less affordable, and

WHEREAS, in that release, Governor Hochul said, "Too many New Yorkers are already falling behind on their energy bills and I will do everything in my power to reign in these astronomical costs," and

WHEREAS, now Governor Hochul's Department of Public Service is considering a proposed from National Grid to significantly increase their rates for electric and gas delivery to their consumers, and

WHEREAS, the proposed rate hike would result in total monthly increases for the average residential customer of approximately \$18.92 (15%) for electric and \$18.34 (20%) for gas, and

WHEREAS, this drastic rate increase will create significant challenges for communities, businesses and families who are already struggling financially, possibly causing even more residents to flee the state, and

WHEREAS, this situation further highlights problems with the state's unaffordable and unsustainable energy goals and climate policies, including the Climate Leadership and Community Protection Act (CLCPA), and the significant costs associated with implementing them, and

WHEREAS, just as Governor Hochul demanded that NYPA "go back to the drawing board, shelve this existing proposal, and figure out a better way forward," the Governor should demand the same from National Grid, now, therefore, be it

RESOLVED, that the Niagara County Legislature hereby vehemently opposes the proposed rate increase by National Grid as not reasonable or warranted and demands the Department of Public Service reject the proposed rate increase which threatens to jeopardize economic stability for numerous families and businesses, and be it further

RESOLVED, that the Niagara County Legislature calls on Governor Hochul to publicly oppose this staggering rate hike scheme just as she opposed the NYPA proposal, and be it further

RESOLVED, that copies of this resolution be forwarded to Governor Kathy Hochul, the Niagara County delegations to New York State Legislature and any other party deemed necessary and proper.
