



WHEREAS, the Town of Lockport Assessor's office initiated an application for a correction of error pertaining to the 2024/2025 Lockport City School Tax for certain property located in the Town of Lockport and identified as Parcel ID 292600: # 110.02-2-52 located at 4905 Keck Road, and

WHEREAS, the proposed correction of error was approved by the Niagara County Real Property Tax Services Director and presented to the Niagara County Treasurer for enforcement, and

WHEREAS, after thorough review of the facts and circumstances surrounding the same, it has been determined that the aforementioned application for a correction of error was done in error, and

WHEREAS, the final 2025 Niagara County tax warrant, as amended, owing from the Town of Lockport has been satisfied, and

WHEREAS, the Town of Lockport Assessor and Niagara County Real Property Tax Services Director have deemed the aforementioned unpaid school tax an omitted tax under Real Property Tax Law § 551, allowing for recoupment of the same by Niagara County on the 2026 Town/County bill, and

WHEREAS, the Lockport City School District remains owed the base unpaid amount plus 3% statutory interest relative to this property, now, therefore, be it

**SOLE SOURCE STANDARDIZATION OF ANNUAL SYSTEM MAINTENANCE**  
**AND HOSTING OF TAX COLLECTION SOFTWARE SYSTEM TO SYSTEMS EAST, INC.**

WHEREAS, the Niagara County Treasurer's Office has utilized a very customized Tax Collection Software System from Systems East, Inc. (TCS) since 2003, and

WHEREAS, Systems East, Inc. hosts the software rather than it being hosted on client's servers, which increases the ease with which they can provide upgrades and support, and

WHEREAS, there is an annual maintenance cost for hosting and the annual maintenance cost for 2026 is \$38,690.00, and for 2027 is \$39,314.00 and

WHEREAS, Systems East, Inc. is the sole source for hosting and annual maintenance of its own software system, now, therefore, be it

RESOLVED, that for reasons of efficiency and economy, pursuant to General Municipal Law 103(5), there is a need for standardization for the Niagara County Treasurer's Office in the purchase of annual service maintenance and hosting for the Systems East, Inc. TCS Tax Collection Software system, and be it further


RESOLVED, that it is hereby determined that Systems East, Inc., is the sole source vendor for the annual service maintenance and hosting for the TCS Tax Collection Software system, and that the Niagara County Treasurer's Office is hereby authorized to purchase the annual service maintenance and hosting for the TCS Tax Collection Software system directly from Systems East, Inc., without the need to solicit for alternate proposals, such purchase to be made in consultation with Purchasing Department and in accordance with budgetary procedures, and be it further

Mylan Pharmaceuticals, Sun Pharmaceuticals, Zydus Pharmaceuticals, and their subsidiaries regarding the companies' manufacturing and distribution of opioids; and



## APPROVAL OF TERMINATION OF RIGHT OF REVERTER 80 BRIDGE STREET, NORTH TONAWANDA, NY

WHEREAS, In 2008 the Niagara County Legislature sold the fire training tower and grounds located at 80 Island Street, North Tonawanda, NY (SBL 184.08-1-9) to the City of North Tonawanda (Resolution PW-016-08 from February 5, 2008), and

WHEREAS, Pursuant to the deed recorded June 24, 2008, a number of deed restrictions were established including a condition that the City of North Tonawanda not sell the parcel within the next five years, and if violated all proceeds will revert to the County of Niagara, and

WHEREAS, further deed restrictions indicate that the facilities and premises will not be used to conduct rappelling operations or induce fires, that the City shall maintain the facility and grounds and that the City assumes all liability and agrees to defend and indemnify the County against any and all liability issues, and

WHEREAS, the City now wishes to sell the property to Bridge Street Landing, LLC for development, and

WHEREAS, to finalize said sale, the City is required to furnish a termination of the right of reverter signed by the County releasing deed restrictions, and

WHEREAS, the City of North Tonawanda has requested the County assist them in signing a termination of the right of reverter, as said sale would be in the best interest of the residents of the City of North Tonawanda, now, therefore, be it

RESOLVED, that the County of Niagara agrees to sign the termination of right of reverter to release certain conditions in the recorded deed, and be it further

RESOLVED, that the City of North Tonawanda shall continue to defend and indemnify the County against all liabilities with regards to the Property, and be it further

RESOLVED, that should the City fail to sell said property to Bridge Street Landing LLC, the termination of right of reverter shall be cancelled and deemed null in void, and be it further

RESOLVED, that following the County Attorney's review, the Chairman of the Legislature be, and hereby is, authorized to execute the required document.
