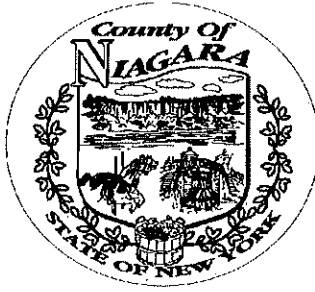

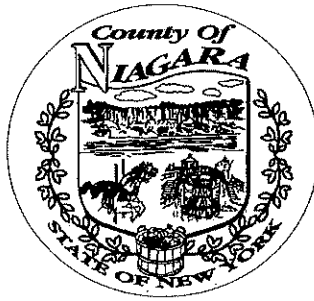

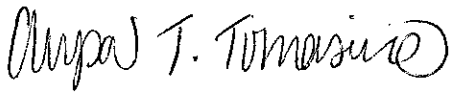

APPOINTMENT ASSIGNED COUNSEL & CONFLICT ADMINISTRATOR

WHEREAS, due to prior representations of witnesses, defendants, and other parties by the Public Defender's Office, a "conflict of interest" is created for the Public Defender's Office to represent certain indigent defendants in criminal proceedings in certain village, town, city, and county courts within the County of Niagara, appeals to the Appellate Division of the New York State Supreme Court, and to the New York State Court of Appeals, and

WHEREAS, the Assigned Counsel and Conflict Administrator position was vacated on June 29, 2026 as a result of a resignation and it is imperative that this Department Head be appointed based upon proven leadership experience and a thorough knowledge of the criminal justice system as it relates to the representation of indigent defendants in criminal proceedings, and

WHEREAS, Mary-Jean Bowman has decades of professional attorney experience with criminal cases and has demonstrated exceptional leadership abilities and has been serving as Interim Assigned Counsel and Conflict Administrator since June 29, 2026, and

WHEREAS, the County Manager has determined that Mary-Jean Bowman best meets the qualifications and possesses the qualities required to serve as Assigned Counsel and Conflict Administrator, and therefore, should be appointed to the position subject to the appointment being confirmed by the County Legislature, and

WHEREAS, the position is fully funded for 2026 in the Assigned Counsel & Conflict Administrator's Office budget, now, therefore, be it

RESOLVED, that Mary-Jean Bowman be appointed Assigned Counsel and Conflict Administrator effective August 4, 2026 at an FLSA exempt annual salary of \$147,000 (pro-rated for the remainder of 2026) with subsequent increases subject to approval in the annual budget and is entitled to all the benefits normally granted to Department Heads for the duration of the appointment.

EXTENSION OF MEDICAL CLAIMS ADMINISTRATION CONTRACT BETWEEN AND AMONG NIAGARA COUNTY, THE NIAGARA COUNTY HEALTH PLAN AND NOVA HEALTHCARE ADMINISTRATORS, INC.

WHEREAS, Niagara County, the Niagara County Health Plan ("NCHP") and the Niagara County Legislature previously authorized the signing and delivery of a current contract between NCHP and Nova Healthcare Administrators, Inc. ("NOVA") for the provision of medical claims administration services through December 31, 2026 for the NCHP, and

WHEREAS, NOVA has rendered professional and competent services to the County and to NCHP pursuant to said contract, and

WHEREAS, NCHP requires, and Nova has offered, to render the same professional services set forth in said agreement for an additional three (3) year contract extension period at the same per employee per month fee and menu of services pricing as 2026 for 2027 with a below market 1.5% increase in years 2028 and 2029, and

WHEREAS, such measures serve to preserve advance rebates and strategically align the TPA medical claims services contract with the current Pharmacy Benefit Administration Services contract term; provides continuity of service and avoids disruption to Members; now, therefore, be it

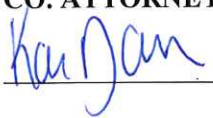

RESOLUTION IN SUPPORT OF NEW YORK STATE ASSEMBLY BILL A7315 AND SENATE BILL S9626 REGARDING CONTRACT REQUIREMENTS FOR GLAZING WORK ON CERTAIN PUBLIC WORKS PROJECTS

WHEREAS, New York State Assembly Bill A7315 and Senate Bill S9626 propose to establish certification requirements for certain glazing work performed on qualifying public works construction projects, and

WHEREAS, glazing work involves specialized skills that are essential to the structural integrity, safety, energy efficiency, and long-term performance of public buildings and infrastructure, and

WHEREAS, ensuring that contractors and workers performing specialized glazing work possess nationally recognized certifications promotes quality workmanship, enhances public safety, and helps protect taxpayer investments in public construction projects, and

WHEREAS, encouraging a highly trained and skilled workforce supports workforce development, creates opportunities for continuing education and professional advancement within the skilled trades, and promotes high standards throughout the construction industry, and

WHEREAS, the Niagara County Legislature recognizes the importance of maintaining high standards of safety, quality, and accountability on publicly funded construction projects, now, therefore, be it

RESOLVED, that the Niagara County Legislature hereby expresses its support for New York State Assembly Bill A7315 and Senate Bill S9626, which establish certification requirements for certain glazing work performed on qualifying public works projects, and be it further

RESOLVED, that the Niagara County Legislature respectfully urges the Governor of the State of New York and the members of the New York State Legislature to give favorable consideration to this legislation, and be it further

RESOLUTION CALLING UPON GOVERNOR KATHY HOCHUL TO IMMEDIATELY DIRECT THE NEW YORK STATE DEPARTMENT OF TAXATION AND FINANCE TO CONDUCT A COMPREHENSIVE AUDIT OF THE INTERNET DATA CENTER SALES TAX EXEMPTION

WHEREAS, Governor Kathy Hochul has publicly acknowledged concerns regarding New York State's decades-old Internet Data Center Sales Tax Exemption and has indicated that legislation concerning the exemption may be considered during the next legislative session, and

WHEREAS, Niagara County has repeatedly raised serious concerns regarding the application of this exemption, particularly as it relates to the Lake Mariner Data Center located in the Town of Somerset, and the substantial financial consequences this tax policy has imposed on local governments and taxpayers, and

WHEREAS, despite the enormous growth of cryptocurrency mining and artificial intelligence data centers throughout New York State, there has been little public transparency regarding the administration of this exemption, who benefits from it, whether recipients are legally eligible, and the true cost to New York taxpayers, and

WHEREAS, the New York State Department of Taxation and Finance has publicly claimed the exemption cost approximately \$12 million in lost state sales tax revenue in the last fiscal year, a figure that appears wholly inconsistent with the scale of investments made by facilities such as Lake Mariner and raises serious questions regarding the accuracy and completeness of the State's reporting, and

WHEREAS, publicly available guidance issued by the Department of Taxation and Finance suggests that certain equipment purchases currently receiving the exemption may not qualify under existing law, creating further concerns that the exemption is being improperly applied and inadequately monitored, now, therefore, be it

RESOLVED, that the Niagara County Legislature strongly urges Governor Kathy Hochul to immediately direct the New York State Department of Taxation and Finance to conduct a comprehensive, independent audit of the Internet Data Center Sales Tax Exemption rather than delaying action until the next legislative session, and be it further

RESOLVED, that such audit should include, at a minimum:

1. Identification of every company currently receiving the Internet Data Center Sales Tax Exemption;
2. A determination of whether cryptocurrency mining operations and artificial intelligence data centers qualify under existing statute and regulation and, if so, identification of the individual or agency responsible for that interpretation;
3. Verification that every recipient is in full compliance with all statutory eligibility requirements;
4. A detailed review of whether all equipment purchases claimed under the exemption qualify under existing law, including an examination of any distinction between purchases made by facility owners and purchases made by tenants operating within those facilities; and

5. A full accounting of the total amount of New York State sales tax revenue forgone as a result of this exemption since its inception, including annual totals and project-specific estimates where available; and be it further

RESOLVED, that the Niagara County Legislature further calls upon Governor Hochul to require the Department of Taxation and Finance to publicly release the complete findings of this audit so that the Legislature, local governments, taxpayers, and members of the New York State Legislature may make informed policy decisions based upon facts rather than speculation, and be it further

RESOLVED, that copies of this resolution be transmitted to Governor Kathy Hochul, the Commissioner of the New York State Department of Taxation and Finance, the Temporary President of the New York State Senate, the Speaker of the New York State Assembly, Senator Rob Ort, Assemblyman Angelo Morinello, Assemblyman William Conrad, Assemblyman Paul Bologna and all others deemed necessary and proper.
