NIAGARA COUNTY LEGISLATURE AUTHORIZATION TO COMPLETE PURCHASE OF CERTAIN PROPERTIES IN THE CITY OF LOCKPORT

WHEREAS, Niagara County has leased office space at 111 Main Street and 20-40 East Avenue in Lockport, New York 14094 since May 1, 2003 respectively, said leases are scheduled to continue through April 30, 2018, and

WHEREAS, the Niagara County Legislature recognized the potential for substantial long-term savings by purchasing the two leased properties when they, along with 50 Main Street, Lockport, were listed for sale at public auction, and

WHEREAS, the Niagara County Legislature authorized a bid of \$3,600,000.00 for said properties at a Special Meeting on March 19, 2015, by the unanimous passage of Resolution CW-004-15, and

WHEREAS, the bid has been accepted by the seller and deposit monies previously remitted by Niagara County, and the county is in receipt of a preliminary closing statement, now therefore be it

RESOLVED, that the Niagara County Legislature hereby approves of the purchase of 111 Main Street, 20-40 East Avenue, and 50 Main Street, Lockport, New York and authorizes the Chairman of Legislature to execute any and all documents necessary to facilitate said purchase, and be it further

RESOLVED, the Niagara County Legislature hereby commits \$3,386,479.73 to the completion of this purchase, for a total commitment of \$3,874,823.85 which is inclusive of purchase price, buyer's premium, prorations and purchaser's closing costs, and be it further

RESOLVED, that following budget modification be effectuated to satisfy the 2015 funding support:

NIAGARA COUNTY LEGISLATURE AUTHORIZATION TO ENTER INTO NEGOTIATIONS WITH CITY OF LOCKPORT AND LOCKPORT CITY SCHOOL DISTRICT ON IMPACT OF COUNTY PURCHASE OF 111 MAIN STREET, 20-40 EAST AVENUE AND 50 MAIN STREET, LOCKPORT, NEW YORK

WHEREAS, Niagara County has leased office space at 111 Main Street and 20-40 East Avenue in Lockport, New York 14094 since May 1, 2003 respectively, said lease are scheduled to continue through April 30, 2018, and

WHEREAS, the Niagara County Legislature recognized the potential for substantial long-term savings by purchasing the two leased properties when they, along with 50 Main Street, Lockport, were listed for sale at public auction, and

WHEREAS, the Niagara County Legislature authorized a bid of \$3,600,000.00 for said properties at a Special Meeting on March 19, 2015, by the unanimous passage of Resolution CW-004-15, and

WHEREAS, the Niagara County Legislature, in its assessment of long term savings, also considered the impact on the real property taxing authorities, and

WHEREAS, prior to the auction, the Niagara County Legislature reached out to New York State Power Authority concerning utilizing low cost power to lessen the budget impact on the School District, and

WHEREAS, prior to the auction, the Niagara County Legislature reached out to the City of Lockport concerning services they could provide to alleviate a parking problem that has existed for 12 years, and in lieu the County could reimburse the City for these services, and

WHEREAS, both of these preemptively considered measures were investigated to find ways to minimize the budget impact on the taxing jurisdiction; if the Niagara County Legislature ended up purchasing the properties, as they have, and

WHEREAS, the bid has been accepted by the seller and deposit monies previously remitted by Niagara County, and

WHEREAS, the Niagara County Legislature having approved the purchase of 111 Main Street, 20-40 East Avenue, and 50 Main Street, Lockport, New York, and having authorized the Chairman of the Legislature to execute any and all documents necessary to facilitate said purchase, and

WHEREAS, Niagara County Legislature seeks to lessen any negative budget impact on the taxing authorities, and

RESOLVED, that the Niagara County Legislature authorizes the entering into negotiations with the City of Lockport for services including additional parking for its building purchased at 20-40 East Avenue and 111 Main Street, be it further

RESOLVED, that the Niagara County Legislature authorize the entering into negotiations with Lockport City School District for the use of an allocation of low cost power, and be it further

RESOLVED, that final agreements are subject to approval of the Niagara County Legislature. Moved by Updegrove ,seconded by Andres. Adopted. 9 Ayes, 0 Noes, 6 Absent - Hill, Lance, McNall, Nemi, Syracuse & Virtuoso
