RESOLUTION IN SUPPORT OF FEDERAL LEGISLATION H.R.6929/S.3766 THE SUSAN MUFFLEY ACT TO RESTORE PENSION BENEFITS TO OVER 20,000 DELPHI SALARIED RETIREES

WHEREAS, Niagara County is home to many retirees who once worked at the Delphi Plant in Lockport, and

WHEREAS, during the Great Recession economic crisis of 2008-2009, General Motors filed for bankruptcy and the pensions of certain Delphi retirees were cut by the U.S. Pension Benefit Guarantee Corporation, impacting more than 20,000 Delphi retirees nationally, including many in our community, and

WHEREAS, while the federal government bailed out General Motors, nothing has been done to restore the pension of these workers who played by the rules and are now suffering financial hardship through no fault of their own, and

WHEREAS, there has been legislation introduced in Congress to right this terrible wrong and restore full pension benefits, called the Susan Muffley Act, and

WHEREAS, the Susan Muffley Act is named after former Delphi employee David Muffley's wife, as David worked at Delphi for over 30 years as an electronics technician, but lost the full value of his pension in 2009, which led his wife Susan, who was diagnosed with pancreatic cancer, to avoid seeking medical care because of financial constraints, and she passed away in 2012, now, therefore, be it

A RESOLUTION IN SUPPORT OF THE CREATION OF A SPACE NATIONAL GUARD

WHEREAS, the Niagara Military Affairs Council (NIMAC) is the recognized organization advocating for Niagara Falls Air Reserve Station (NFARS) in our community, working to protect the 3,000 jobs on the NFARS and the hundreds of millions of dollars of economic impact generated within our community, and

WHEREAS, NIMAC views the establishment of a Space National Guard (SNG) as critical to the future of 107th Attack Wing (ATKW) located at Niagara Falls Air Reserve Station, building on the fact that the 222nd Command and Control Squadron (CACS) presently performs a space mission and is a part of the 107th ATKW, and

WHEREAS, the reasons for a Space National Guard include that a SNG ensures an ability to mobilize and surge for warfare and limits the ability of any administration to commit significant forces without the support of the American people; SNG units facilitate a better civil-military relationship and allow Americans to serve in the military the opportunity to work full-time in their state, close to their families; SNG is likely to advance military space innovation because of the stability provided and the ability to access innovative ideas from the private sector; there would be significant economic development from the SNG within the host community; SNG protects the independence of the Space Force, and

Section 3. The fifteen Legislative Districts as previously bounded and described by Local Law No. 1 of 2011 shall continue as such for the limited purpose of continuing in office the legislators presently elected from said districts and shall cease to exist as such on January 1, 2023. For purposes of filling vacancies occurring other than by the expiration of term in the offices of member of the Niagara County Legislature elected at the election of two thousand twenty-one, the Legislative Districts of this county, as described and set out in Local Law No. 1 of 2011, shall continue to be the Legislative Districts of Niagara County until December 31, 2021, for the purpose of the general election of 2021 and all other purposes, except as herein provided. Provided, further however that in the event a proposition for the approval of this local law is submitted at the next general election held not less than sixty days after the filing of such a petition, the Legislative Districts as described in Local Law No. 1 of 2011 shall continue to be the Legislative Districts as described in Local Law No. 1 of 2011 shall continue to be the Legislative Districts of Niagara County and Local Law No. 1 of 2011 shall continue to be the Legislative Districts of Such a petition, the Legislative Districts as described in Local Law No. 1 of 2011 shall continue to be the Legislative Districts of Hermited at the next general election held not less than sixty days after the filing of such a petition, the Legislative Districts as described in Local Law No. 1 of 2011 shall continue to be the Legislative Districts of the adoption of a valid Local Law redistricting the Legislature pursuant to Municipal Home Rule Law section (10)(ii)(a.)(13).

Section 4. Each Legislative District created by this Local Law shall be deemed a separate district for purpose of apportionment of the entire county into Legislative Districts. If one or more Legislative Districts created by this local law are judicially found not to be in compliance with the decisions and mandates of a court of competent jurisdiction, only the defective district or districts and those immediately adjacent or contiguous thereto shall be reapportioned. All other districts shall be deemed to be properly constructed.

Section 5. All other provisions of prior applicable local laws of Niagara County not in conflict with the provisions herein shall remain in full force and effect.

Section 6. The Niagara County Legislature, from the districts created herein, shall be first elected at the general election in the year 2023 and shall assume office January 1, 2024.

Section 7. This local law shall be subject to a permissive referendum and shall not take effect until at least 45 days after adoption.

Section 8. This local law shall take effect on filing with the Secretary of State of the State of New York.
