NIAGARA COUNTY LEGISLATURE: FILLING VACANCY OF COUNTY LEGISLATOR LAW

- Section 1. Title. This Local Law shall be known as Niagara County Legislature Filling Vacancy of County Legislator Law.
- <u>Section 2. Purpose.</u> The purpose of this Local Law is to regulate how a vacancy in the office of Niagara County Legislator shall be filled.
- Section 3. Text. A vacancy otherwise than by the expiration of a term in the office of County Legislator shall be filled by appointment by the County Legislature of a qualified elector of the Legislative District in which the vacancy occurred with a person affiliated with the same political party as the County Legislator whose vacancy is being filled. The person appointed by the County Legislature shall hold office by virtue of such appointment pursuant to Article 13, Section 13 of the Constitution of the State of New York and such other laws as may be applicable.
- Section 4. Effective Date. This Local Law shall become effective forty-five (45) days after its adoption.
- Section 5. Superseding. This Local Law is expressly to supersede and replace Section 8 of Local Law #2 of the year 1968.
