- 1. The salary of the Commissioners of Election shall be increased in the sum of \$1,066 each, effective 45 days after adoption of this Local Law, with a lump sum installment to be paid as soon as possible for the past services rendered from January 1, 1994, and the balance of the increase to be paid in equal installments over the remaining pay periods. Effective retroactive to January 1, 1994, the annual salary of the Commissioners of Election shall be \$35,464 each.
- 2. The salary of the Probation Director shall be increased in the sum of \$1,422, effective 45 days after adoption of this Local Law, with a lump sum installment to be paid as soon as possible for the past services rendered from January 1, 1994, and the balance of the increase to be paid in equal installments over the remaining pay periods. Effective retroactive to January 1, 1994, the annual salary of the Probation Director shall be \$47,286.
- 3. The salary of the Director of Real Property Tax Services shall be increased in the sum of \$1,179, effective 45 days after adoption of this Local Law, with a lump sum installment to be paid as soon as possible for the past services rendered from January 1, 1994, and the balance of the increase to be paid in equal installments over the remaining pay periods. Effective retroactive to January 1, 1994, the annual salary of the Director of Real Property Tax Services shall be \$39,227.

4. The salary of the Commissioner of Social Services shall be increased in the sum of \$1,609, effective 45 days after adoption of this Local Law, with a lump sum installment to be paid as soon as possible for the past services rendered from January 1, 1994, and the balance of the increase to be paid in equal installments over the remaining pay periods. Effective retroactive to January 1, 1994, the annual salary of the Commissioner of Social Services shall be \$53,503.
