A LOCAL LAW ESTABLISHING AN ALTERNATIVE METHOD FOR COLLECTION OF DELINQUENT VILLAGE TAXES

- Section 1. This Local Law is enacted pursuant to the authority of Real Property Tax Law, Section 1442 (1) which authorizes the legislative body of any county, upon the enactment of a local law, to provide for the collection of delinquent village taxes if such collection is requested by resolution of the board of trustees of any village within such county.
- Section 2. The Villages of Barker, Lewiston, Middleport, Wilson, and Youngstown have requested by resolution that the County of Niagara collect all of the delinquent taxes on the current tax rolls of the respective villages.
- Section 3. The County of Niagara hereby agrees to collect the current delinquent taxes of the Villages of Barker, Lewiston, Middleport, Wilson, and Youngstown, pursuant to the provisions of Real Property Tax Law, Section 1442.
 - Section 4. This Local Law shall take effect immediately.
