A LOCAL LAW ELECTING AN EARLY RETIREMENT INCENTIVE PROGRAM AS AUTHORIZED BY CHAPTER 41 LAWS OF 1997 FOR THE ELIGIBLE EMPLOYEES OF THE COUNTY OF NIAGARA

- Section 1. The County of Niagara hereby elects to provide all of its eligible employees with a retirement incentive program authorized by Chapter 41 Laws of 1997.
- Section 2. The commencement date of the retirement incentive program shall be November 24, 1997, and extend to December 30, 1997, in which eligible employees may retire and receive the additional retirement benefit.
- Section 3. The actuarial present value of the additional retirement benefits payable pursuant to the provisions of this local law shall be paid as one (1) lump sum or in five (5) annual installments. The amount of the annual payment shall be determined by the actuary of the New York State and Local Employees' Retirement System, and it shall be paid by the County of Niagara for each employee who receives the retirement benefits payable under this local law.

Section 4. This act shall take effect September 2, 1997.
