It shall be the obligation of every dog owner or person having possession, custody, or control of a dog to remove any feces left by said dog on any property within the boundaries of any Niagara County park and deposit the feces in a sealed container lawfully used for the disposal of refuse. The provisions of this section shall not apply to a dog owner or person who is disabled as defined in Agriculture and Markets Law, Section 108, and who has possession, custody, or control of a guide dog, hearing dog, or service dog as defined in Agriculture and Markets Law, Section 108.

Any violation of the above provision shall be considered a violation and shall be punishable by a fine of not more than One Hundred Dollars (\$100.00).

A copy of this Local Law shall be distributed to the Niagara County Sheriff's Department and all law enforcement organizations within Niagara County.

This Local Law shall become effective 45 days after its adoption, during which time said Local Law is subject to a permissive referendum.
