A LOCAL LAW OF THE COUNTY OF NIAGARA AUTHORIZING A LEASE OR LICENSE AGREEMENT WITH UPSTATE CELLULAR NETWORK FOR A CELLULAR TELEPHONE INSTALLATION LOCATED AT THE NIAGARA COUNTY MOUNT VIEW FACILITY

- Section 1. Notwithstanding the provisions of Section 215(4) of the County Law, after a determination by the Niagara County Legislature that County-owned property is not required for public use, such property may be leased to one or more holders of a license issued by the Federal Communications Commission or a Certificate of Public Convenience and Necessity issued by the New York State Public Service commission authorizing such holder or holders to provide cellular telephone and other wireless communications services in the Niagara County service area for a period not exceeding twenty-five (25) years upon such terms and conditions as may be prescribed by the Niagara County Legislature by resolution in the same manner and with the same rights and privileges as if such property were owned by an individual.
- <u>Section 2</u>. Insofar as the provisions of this local law are inconsistent with the provisions of any other local law or act, the provisions of this local law shall be controlling.
- <u>Section 3</u>. The County Legislature has reviewed the potential environmental impacts and found that the granting of this lease shall not result in any adverse environmental impact and, therefore, issues a negative declaration pursuant to SEQRA.
 - <u>Section 4</u>. This local law shall take effect immediately.
