A LOCAL LAW AMENDING LOCAL LAW NO. 5 FOR THE YEAR 1998

1. Local Law No. 5 for the year 1998, and the same hereby is, amended so as to delete Section 3 thereof in its entirety and insert therein a new Section 3, to read as follows:

<u>Section 3</u>. Filling Vacancy in Elective Office of County Legislator.

A vacancy, otherwise than by the expiration of a term in office, in the elective office of County Legislator, shall be filled by appointment by the County Legislature based upon the recommendation of a majority of the County Legislators of the same political affiliation with which the person last elected to such office was registered. A vacancy shall be included in the total count when said recommendation is being made by a majority of the County Legislators of the same political affiliation. The recommendation shall be communicated in writing and filed with the Clerk of the County Legislature. Provided, however, that if the County Legislature shall fail to appoint any person recommended within thirty (30) days after this filing, then the majority of the County Legislators of the same political affiliation with which the person last elected to such office was registered may appoint such person. In the event that the vacancy in the elective office of County Legislator is of a person who is the sole member of the political affiliation with which the person last elected to such office was registered, the vacancy shall

be filled by the majority vote of the County Legislature with a person of the same political affiliation. The person newly appointed shall be a qualified elector of the County and shall be a resident of the district to which such appointment is made. The person appointed shall hold office by virtue of such appointment pursuant to Article 13, Section 3 of the Constitution of the State of New York and such other laws as may be applicable.
