- The Department shall be responsible for providing a properly planned, organized, equipped, trained and exercised emergency management and homeland security force capable of preparing for and responding to public emergencies and homeland security incidents, including those that originate along the international border that may have a significant impact on the safety and security of local residents, businesses and the larger surrounding region. Departmental responsibilities shall include planning, organizing, maintaining, mobilizing, and implementing such emergency preparedness and readiness plans as may be necessary to protect the general public safety, health and welfare.
- 2. The Department shall be headed by a Director of Homeland Security and Emergency Management ("Director") who shall be responsible for the coordination and mobilization of available resources in response to public emergencies and for administering the County's homeland security and emergency preparedness programs and services. The Director shall supervise the County Fire Coordinator and be responsible overall for overseeing fire coordination and emergency management programs and activities for the county.
- 3. The Director shall be under the general direction of the County Manager and shall be charged with carrying out the details of the Departmental work in accordance with all applicable regulations and guidelines.
- 4. The Director serves in the capacity of a department head and has the authority to appoint and remove employees of the Department.
