- 1. Local Law No. 4 for the year 1977 be amended to establish the Department of Solid Waste for the County of Niagara as a division of the Department of Public Works for the County of Niagara, under the direction of the Environmental Science Coordinator.
- 2. The establishment of divisions of the Department of Public Works shall be amended to read:

There shall be the following divisions within the Department of Public Works: Division of Highways, Bridges and Structures, Division of Buildings, Grounds and Parks, Division of Engineering, each of which shall be headed by a Deputy who shall be appointed by the Commissioner of Public Works provided however, that the Deputy Director of Highways, Bridges and Structures shall perform and be responsible for such activities as are required of a Superintendent of Highways. Division of Solid Waste Management which shall be headed by the Environmental Science Coordinator who shall be appointed by the Commissioner of Public Works.

3. This Local Law shall take effect upon filing in the Office of the Secretary of State, as provided by Section 27 of the Municipal Home Rule Law.
