REORGANIZATION - ABOLISH SENIOR PERSONNEL RECORD CLERK/

CREATE PERSONNEL RECORD CLERK - HUMAN RESOURCES

WHEREAS, a Senior Personnel Record Clerk position will become vacant due to a retirement on June 29, 2022, and

WHEREAS, the Director of Human Resources has analyzed the needs of the department, evaluated the likely recruitment field, and consulted with the Personnel Officer and County Manager, and

WHEREAS, it has been determined that reclassifying the vacancy will allow for the greater likelihood of recruiting a qualified candidate to meet the operational needs, will provide for growth and development opportunities for a mid-level position, and the duties of the position are most accurately reflected in the Personnel Record Clerk job specification, and, therefore be it

RESOLVED, that the Senior Personnel Record Clerk, NUH grade 62 \$44,688 - \$52,763, position #193 will be abolished and a Personnel Record Clerk, NUH grade 61 \$41,034 - \$48,397, will be created and filled effective July 10, 2022.
