Review of the April 2020 Financial Report showed an Operation and Maintenance balance of \$10,796,692.40.

Upon motion duly made by Mark C. Crocker and seconded by Don MacSwan, it was resolved that the Sewer District's April 2020 Financial Report be approved as presented. This motion was carried.

Communications:

a. NYS Canal Corp Canalway Trail Phase 2 Correspondence - Mr. Blodgett referred to Attorney Vona and Bob Lannon of GHD to update the Board regarding recent written and verbal correspondence regarding the Canalway Trail Phase 2 project. Mr. Lannon stated the District wrote a letter dated April 24, 2020 alerting the Canal Corp that any damage to the District infrastructure must be fully repaired to the satisfaction of the NCSD. Initially the Canal Corp responded in writing May 22, 2020 indicating the District does not have an easement on the property, but rather a revocable permit dated January 2, 1976, which remains in effect. The Canal Corp requested the District mark the horizontal and vertical location of the infrastructure with ground penetrating radar (GPR), and the Canal Corp would direct its contractor to allow a NCSD representative on site to observe the excavation work scheduled to commence on or about June 1, 2020. Mr. Vona stated that in most general construction language in NYS Municipal Contracts obligates contractors to protect existing infrastructure. He stated that in a follow-up call from the Attorney for the Canal Corp acknowledged they have to take responsibility for any potential damages per the contractual language to protect existing infrastructure.

Old Business:

There is nothing new to report this month.

Chief Operator's Report:

a. Townline and Rapids Road Pump Repairs - Mr. Earsing presented three quotes for pumps to be rebuilt at the Townline and Rapids Road pump stations as part of the District's I/I reduction program. These pumps were previously identified as needing upgrades as part of detailed pump station analysis performed by GHD a few years ago. He noted Moley Magnetics bid was significantly lower than the others and Moley has recently done satisfactory pump rebuild work for the District. He requested authorization to accept the low bid from Moley Magnetics of \$23,945.66 to rebuild pumps at the Townline and Rapids Road stations.

Upon motion duly made by Mark C. Crocker and seconded by Steve Broderick, it was resolved that the Administrative Board of Niagara County Sewer District #1 hereby authorizes Mr. Earsing to accept the low bid from Moley Magnetics of \$23,945.66 to rebuild pumps at the Townline and Rapids Road stations. This motion was carried.

b. O.E.M. Interceptor Manhole Linings - Mr. Earsing stated as another component to the District I/I program he presented two quotes from Advanced Rehabilitation Technologies, a sole source installer of a three-part manhole liner system. Mr. Earsing requested Board authorization to accept the sole source proposal from Advanced Rehabilitation Technology for lining of Manhole 1-40 with traffic control services for \$5,750.00.

Upon motion duly made by Don MacSwan and seconded by Mark C. Crocker, it was resolved that the Administrative Board of Niagara County Sewer District #1 hereby authorizes Mr. Earsing to accept the sole source proposal from Advanced Rehabilitation Technology for lining of Manhole 1-40 with traffic control services for \$5,750.00. This motion was carried.

Mr. Earsing presented a second proposal from Advanced Rehabilitation Technology to line other District manholes that have been prioritized as significant sources of inflow and infiltration, under the District's I/I program, Mr. Earsing requested Board authorization to accept the sole source proposal from Advanced Rehabilitation Technology to install liner system of prioritized NCSD manholes @ \$298.00 per vertical foot not to exceed \$20,000.00.

Upon motion duly made by Mark C. Crocker and seconded by Steve Broderick, it was resolved that the Administrative Board of Niagara County Sewer District #1 hereby authorizes Mr. Earsing to accept the sole source proposal from Advanced Rehabilitation Technology to install liner system of prioritized NCSD manholes @ \$298.00 per vertical foot not to exceed \$20,000.00. This motion was carried.

Administrative Directors Report:

a. Summer/Seasonal Employment - Mr. Blodgett reported there are 3 seasonal positions yet to be filled due to delays from the COVID-19 restrictions. He stated in the past, reaching out to area high schools and colleges has been beneficial to filling these positions, however; schools have been closed since March from the COVID-19 concerns. He stated efforts will be made to fill the positions and encouraged Commissioners to feel free to recommend any candidates they may be aware of.

b. Town I/I Projects - Mr. Blodgett reminded all of the Commissioners who have I/I projects in the works to submit their paperwork soon in order to receive their individual Town's \$20,000.00 allocated I/I funds for the 2020 fiscal year. Mr. Blodgett encouraged Commissioners or their appropriate town personnel to contact Mr. Lannon or himself for any assistance or to discuss any potential I/I projects.

c. Sludge Disposal Bid - Mr. Blodgett stated the 3 year current contract with Modern
Disposal, Inc. expires on September 30, 2020. Mr. Blodgett requested Board authorization to prepare the specifications and advertisement for bid for a new contract.

Upon motion duly made by Don MacSwan and seconded by Mark C. Crocker, it was resolved that the Administrative Board of Niagara County Sewer District #1 hereby authorizes the Administrative Director to obtain bids for a new Sludge Hauling and Disposal Contract. This motion was carried. d. Milton CAT Scheduled Generator Maintenance Agreement - Mr. Blodgett reviewed a proposal from Milton Cat for maintenance of the emergency generators at the Plant, and Mapleton and Townline Road pump stations. Mr. Blodgett requested Board authorization to accept and sign a 3 year contract with the price of \$40,093.08 total for the 3 year contract.

Upon motion duly made by Joel M. Maerten and seconded by Steve Broderick, it was resolved that the Administrative Board of Niagara County Sewer District #1 hereby accepts the proposal of Milton Cat (Contract term May 1, 2020 - April 30, 2023) with the price of \$40,093.08 total for the 3 year contract, and authorizes the Administrative Director to sign and execute said Contract. This motion was carried.

e. 2021 Budget Schedule - Mr. Blodgett reported that the 2020 Budget schedule is already upon us and that a tentative Budget will be presented to the Commissioners in July, and then the final tentative budget for Board approval in August for presentation to the Niagara County Budget Office in September.

f. Maintenance Person II – Retirement - Mr. Blodgett presented a letter from Daniel P. Daboll, Maintenance Person II, informing the District of his retirement effective May 30, 2020, after 33 years and 6 months of service to the District. Mr. Blodgett and the Commissioners thanked Mr. Daboll for his dedicated years of service to the District. Commissioner MacSwan requested an official Proclamation signed by the Chairman be presented to Dan Daboll thanking him for all his years of service and wishing him well in his retirement.

Upon motion duly made by Don MacSwan and seconded by Mark C. Crocker, it was resolved that the Administrative Board of Niagara County Sewer District #1 hereby accepts the resignation of Daniel P. Daboll, Maintenance Person II and to issue an Official Proclamation from the Chairman thanking him for all his years of dedicated service to the District. This motion was carried.
