Mr. Blodgett stated the Executive Orders and emergency mandate powers granted to Governor Cuomo during the Covid-19 Pandemic expire June 24th. Mr. Blodgett suggested resuming normal meetings at the District starting in July and moving forward, and the Commissioners agreed.

Chief Operator's Report:

a. Federal Pacific 480V Breaker Removal, Repair and Reinstallation – Mr. Earsing stated that during routine preventative maintenance there was a noticeable delay with one of the districts Federal Pacific 480 volt breaker when manually tripped. Mr. Earsing presented three bids and requested Board authorization to accept the low bid from O'Connell Electric of \$5,557.00 to repair the breaker.

Upon motion duly made by Don MacSwan and seconded by Lee Wallace, it was resolved that the Administrative Board of Niagara County Sewer District #1 hereby approves Mr. Earsing's request to accept the low bid from O'Connell Electric of \$5,557.00 to repair the Federal Pacific 480V Breaker. This motion was carried.

Administrative Directors Report:

a. 2020 Audit Schedule- Drescher & Malecki – Mr. Blodgett reported representatives from Drescher & Malecki will be available at the July Administrative Board Meeting to address the annual

audit report. A draft of the report and presentation highlights will be forwarded to the Board prior to the July meeting.

- b. Teamsters Union Negotiations Mr. Blodgett stated talks are ongoing. The County is still waiting to hear from the Union to schedule the next meeting.
- c. 2022 Budget Mr. Blodgett stated he has met with District staff and Mr. Lannon from GHD to discuss ideas and future projects for 2022 budget planning. He said the tentative 2022 budget will be presented to the Board at the July meeting for review and discussion. Mr. Blodgett said he would need to request authorization to approve the Tentative Budget at the August meeting in order to present the proposed departmental 2022 Budget to the County Budget Office in early September.
