Upon motion duly made by Steve Broderick and seconded by Joel M. Maerten, it was resolved that the Sewer District's August and September 2023 Financial Report be approved as presented. This motion was carried.

Communications:

Old Business:

There is nothing new to report this month.

Chief Operator's Report:

<u>a.</u> Submersible Pump Plant Tank Maintenance – Mr. Blodgett stated the maintenance department uses large submersible pumps when plant process tanks such as the chlorine contact and aeration tanks are emptied for cleaning. He presented three quotes and requested approval to purchase a 4" submersible pump from Xylem, the lowest bidder, for \$13,367.00.

Upon motion duly made by Don MacSwan and seconded by Steve Broderick, it was resolved to approve Mr. Blodgett's request to purchase a 4" submersible pump from Xylem, the lowest bidder, for \$13,367.00. This motion was carried.

b. OEM Purchase – Raw Sewage Pump Check Valve Assemblies – Mr. Blodgett stated in March the Board approved ordering one check valve assembly kit and our maintenance personnel recently completed the rebuild of one of the plant's main influent check valves. Mr. Blodgett presented a quote from Blair Supply Corp. for two raw sewage check valve assemblies for \$20,339.64. Mr. Blodgett requested Board approval to purchase two sole source raw sewage pump check valve assemblies from Blair Supply Corp. for \$20,339.64.

Upon motion duly made by Don MacSwan and seconded by Wright H. Ellis, it was resolved to approve Mr. Blodgett's request to purchase sole source raw sewage pump check valve assemblies from Blair Supply Corp. for \$20,339.64. This motion was carried.

c. OEM Purchase of EIM/Bettis Bypass Gate Actuator – Mr. Blodgett stated the main plant bypass gate is very critical for plant operation during wet weather flows. The current actuator is about 25 years old and has recently began triggering position errors on the SCADA system. Mr. Blodgett requested authorization to purchase a new OEM bypass gate actuator from R.M. Headlee for \$10,187.00.

Upon motion duly made by Wright H. Ellis and seconded by Don MacSwan, it was resolved to approve Mr. Blodgett's request to purchase a new OEM bypass gate actuator from R.M. Headlee for \$10,187.00. This motion was carried.

d. (2) 10HP VFD Drives – Sludge Pumps – Mr. Blodgett stated the 25 year old sludge pump VFDs at the plant have been having performance issues and require replacement. He presented three quotes and requested approval to purchase two 10-horsepower VFD drives for the sludge pumps from Ferguson Electric, the lowest bidder, for \$10,997.00.

Upon motion duly made by Joel M. Maerten and seconded by Steve Broderick, it was resolved to approve Mr. Blodgett's request to purchase two 10-horsepower VFD drives for the sludge pumps from Ferguson Electric, the lowest bidder, for \$10,997.00. This motion was carried.

Administrative Directors Report:

a. 2024 Budget and Preliminary Tax Computation Schedule – Mr. Blodgett reported he and Joanne Teixeira met yesterday with the County Manager and Budget Office to review the Tentative 2024 Budget, and the District's final budget will be presented to the Niagara County Legislature for final approval in December.

Mr. Blodgett distributed a spreadsheet containing each individual town's preliminary EDU numbers as provided to us by the Office of Real Property Tax Services. He stated he would coordinate with John Shoemaker at Real Property for the final tax roll EDU and assessment numbers, which are typically available in early November. He urged Commissioners to compare this year's numbers to last year's and reach out to Joanne or himself if they have any questions. A final Tax Computation Spreadsheet will be forwarded to the Board as soon as possible once the final numbers are available.

b. Public Hearing Notification regarding Sewer District Assessment – Mr. Blodgett reported that the District is responsible for notifying property owners subject to special assessments of the public hearing regarding the 2024 budget. In the past, postcards have been sent to property owners in the Towns of Pendleton, Lewiston, and Wheatfield with assessments of \$350,000 and above. Mr. Blodgett requested Board authorization to send out said notifications for this year.

Upon motion duly made by Wright H. Ellis and seconded by Don MacSwan, it was resolved that the Administrative Board of Niagara County Sewer District #1 hereby authorizes Mr. Blodgett to notify property owners, subject to special assessments with assessed values of \$350,000 and above in the Towns of Lewiston, Pendleton, and Wheatfield, of the Public Hearing regarding the 2024 County Budget. This motion was carried.

- c. 2024 Emergency Repair Contract Mr. Blodgett reported the current Emergency Repair Contract expires on December 31, 2023. He stated he would begin to work with GHD to seek bids for a new emergency repair contract for 2024. The proposed rates and contractors will be presented for review and approval once they are obtained.
- d. Niacet Agreement Mr. Blodgett distributed the tentative Niacet agreement and stated Niacet has requested a one-year instead of a three-year contract. He noted the District proposal included a significant rate increase due to our operating costs, especially sludge disposal and chemicals used to treat their waste. He requested Board authorization to approve and execute the Niacet agreement.

Upon motion duly made by Don MacSwan and seconded by Wright H. Ellis, it was resolved that the Administrative Board of Niagara County Sewer District #1 hereby approves Mr. Blodgett's request for Board approval to authorize Chairman Mark C. Crocker to execute the Wastewater Treatment Services Agreement between Niacet and the Niagara County Sewer District No. 1 (NCSD) contract on behalf of the District. This motion was carried.

- e. 2023 Town I/I Requests Mr. Blodgett stated the District has approved 2023 Town I/I project requests from every town with the exception of Pendleton. He reminded Supervisors to be sure to submit their paperwork so that those funds can be reimbursed.
- f. Maintenance Position Mr. Blodgett stated four applications were received and two candidates were interviewed for the open temporary maintenance position. He requested Board authorization to hire Joshua Mielcarek to fill the vacant temporary Wastewater Maintenance Person position.

Upon motion duly made by Joel M. Maerten and seconded by Wright H. Ellis, it was resolved to authorize Mr. Blodgett to hire Joshua Mielcarek to fill the vacant temporary Wastewater Maintenance Person position. This motion was carried.

i. Upcoming Chemical bids – Sodium Hypochlorite and Liquid Polymer – Mr. Blodgett reported the District's sodium hypochlorite and liquid polymer contracts are both due for renewal soon.

He stated the liquid polymer expires in February 2024, but the potential bidders need time to arrange on site testing prior to submitting bids. At this time Mr. Blodgett is requesting authorization to advertise for bids for sodium hypochlorite and liquid polymer contracts.

Upon motion duly made by Steve Broderick and seconded by Don MacSwan, it was resolved that the Administrative Board of Niagara County Sewer District #1 hereby authorizes the Administrative Director to advertise for bids for sodium hypochlorite and liquid polymer contracts. This motion was carried.

b. Town of Wheatfield 2023 I/I Request – Mr. Blodgett presented a request from the Town of Wheatfield for their 2023 I/I project of repairing an 8" pipe patch in a sewer main on Niagara Falls Boulevard and various manhole rehabs/relining projects for a total cost of \$20,940.00 and requested reimbursement of \$20,000.00 for their 2023 I/I projects.

Upon motion duly made by Joel M. Maerten and seconded by Wright H. Ellis, it was resolved that the Administrative Board of Niagara County Sewer District #1 hereby approves the Town of Wheatfield's 2023 I/I projects for a total reimbursement of \$20,000.00. This motion was carried.

c. Town of Pendleton Connection Request – Mr. Blodgett reported that the Town of Pendleton requests Board approval to connect into the Niagara County Sewer District #1 Manhole #3-09 in order to provide gravity sewer service for 6764, 6770 and 6772 Transit Road in the Town of Pendleton due to failed on-site septic system testing.

Upon motion duly made by Don MacSwan and seconded by Steve Broderick, it was resolved that the Administrative Board of Niagara County Sewer District #1 hereby approves the Town of Pendleton's request to connect into the Niagara County Sewer District #1 manhole #3-09 in order to provide gravity sewer service for 6764, 6770 and 6772 Transit Road in the Town of Pendleton contingent upon technical review by the District. This motion was carried.
