 - b. Increase Adult OJT funding from \$80K to \$85K motion by T. Jaccarino, seconded by K. Schuler, all in favor, none opposed, approved
 - c. Increase DW ITA/CRT funding from \$20K to \$60K motion by T. Jaccarino, seconded by K. Schuler, all in favor, none opposed, approved
 - d. Increase DW OJT funding from \$20K to \$30K motion by K. Schuller, seconded by T. Jaccarino, all in favor, none opposed, approved
- C. Approve PY19 Adult, DW, Youth and Admin Budgets- motion to approve by K. Schuler, seconded by T. Jaccarino, all in favor, none opposed PY19 budgets approved.

V. Review PY2019 Youth RFP Submissions and Determine Awards - Vote

Prior to discussions, all parties involved with submitted RFPs were kindly asked to leave the room. Vice-Chairman Schuler, a member of the Youth Review Committee, summarized that a total of four proposals had been submitted in response to the advertised Youth RFP. They were: Catholic Charities, Niagara County Community College (NCCC), Niagara County Employment & Training (NCET), and People Inc. He stated that per the issued RFP, the total amount to be awarded may not exceed \$800,000. The four proposals and the youth review committee recommendations were discussed. Ms. Klemer added fiscal comparisons amongst the four proposals.

The following award amounts were proposed:

Fully fund NCET: \$477,065 Fully Fund NCCC: \$234,410

Do not fund Catholic Charities \$0 Do not fund People Inc. \$0

Chairman Feuerman called for approval on fully funding NCET and NCCC, and not funding Catholic Charities or People Inc. Motion to approve by T. Jaccarino, seconded by K. Schuler, all in favor, none opposed, youth awards approved as listed above.

M. Casale inquired if notifications would be sent to the above providers. Chairman Feuerman replied that each party would receive a letter. C. Bright recommended that NCET reach out to People Inc. in a good faith effort to service the population targeted in their youth proposal. Chairman Feuerman agreed and said he would request this of the NCET staff after the meeting.
