Discussion about disincentives to employment at this time including fear and added UI benefits.  Customized Training- Health System Services is getting vrtual Office 365 training thru NCCC for 44 employees.  Virtual Career Fairs- Dennis put us in touch with Rich from Monroe County/ Rochester Works who has some experience with virtual career fairs, using one employer thru Eventbrite. There are other means that involve costs and third party providers that can be expensive. A company that does these is Career Echo.  Bonnie Rice- WDB Remote learning with OJT and now six training classes have been developed including: Hospital Supply Chain, Medical Billing, IT Support and Web Development Summer Youth Program needs applicant with schools and community centers beon closed the flow of applicants is curtailed. DSS will

	supply 16-21 list. TANF/OTDA will fund and the program will focus on virtual learning experiences rather than placement at sites. It is hoped that a tablet can be purchased for each participant who will then receive a stipend for participation.  An RFP is out for youth services which is an \$800K contract. May 5 is deadline. RESTORE	Renee P- Restore is a program thru SUNY UB and the NYSDOL to provide employment services for woman in Erie and Niagara Counties who have been affected by the Opioid epidemic either directly or indirectly.
